Reviews

External

Annually (Autumn term) We commission a Local Authority Safeguarding specialist to do a full audit our safeguarding provision.

Half-termly We meet with our safeguarding link governor to review an aspect of the school's safeguarding provision.

Internal

DSL reviews

Weekly Designated Safeguarding Leads meet to discuss live and ongoing cases, proactive and responsive development of matters relating to safeguarding and child protection.

LABS

Half-termly Inclusion team review of learning, attendance, behaviour and safeguarding.

Supervision

DSL Supervisor meets with DSLs once a month to discuss any issues arising and provide a group supervision space for cases that have impacted on a DSL

Training and Ongoing Professional Development

Annual safeguarding and child protection training for all team members run by DSLs and drawn from updated Local Authority Guidance materials Safer Recruitment Training for Executive Leadership Team

Weekly team briefing and memo carry safeguarding messages and feedback on systems. Memo sent to governors and team.

Safeguarding standing agenda item on all meetings

Team all complete online PREVENT training

Team all complete online safety training

Senior Mental Health Lead and First Aider training

Half-termly team knowledge formative assessments

Culture

Culture of listening and a mindset that 'it does happen here' Relationships between adults and pupils are based on mutual respect; our five values of empathy, respect, trust, courage and gratitude are explicitly and implicitly taught

Children's Voices

Children's Congress are mixed-age meetings in which all children are invited to share ideas to consider how to improve the school

Children's Conferences are fortnightly focus groups hosted the Executive and Associate Headteachers. Feedback is given to teachers.
